RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY AUTHORIZING PARTIAL PAYMENT NO. 4 TO LEVEL-1 CONSTRUCTION, INC. FOR CONSTRUCTION OF WELL NO. 2A

WHEREAS, the Mantua Township Municipal Utilities Authority (MTMUA), with its principal place of business at 397 Main Street, Mantua, New Jersey 08051 entered into a contract with Level-1 Construction, Inc., of Williamstown, New Jersey for the construction of a new well and decommissioning of an existing well for the Mantua Township Municipal Utilities Authority;

WHEREAS, Level-1 Construction, Inc., is seeking partial payment in the amount of \$85,340.85 for the progress of work on Well No. 2A, including: mechanical/piping improvements and a portion of the Well No. 2A electrical system improvements, a portion of the installation of the standby power system, the existing electrical service upgrade, the balance of the installation of the chlorine contact tank and appurtenances and a portion of the Well 2A building construction (building backfill, electrical and masonry);

WHEREAS, Level-1 Construction, Inc. is also seeking partial payment for portion of the contingency allowance to cover the additional work related to Well 2A building electrical updates, the 6" CLDIP water main, the 6" gate valves with boxes and the Class I/II stone foundation/pipe bedding;

WHEREAS, the progress of the work completed has been reviewed and verified and payment is hereby recommended in the amount of \$85,340.85 pursuant to the recommendation of the MTMUA project engineer Mark R. Brunermer, PE, CME by letter dated March 14, 2018, which is incorporated herein at length;

NOW, THEREFORE, BE IT RESOLVED, the Mantua Township Municipal Utilities Authority authorizes partial payment No. 4 to Level-1 Construction, Inc. in the amount of \$85,340.85 for the progress of work completed on the construction of Well No. 2A as outlined in the Sickles & Associates March 14, 2018 letter.
