

**RESOLUTION #2019 – 25**

**RESOLUTION OF MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY  
AUTHORIZING, APPROVING, RATIFYING AND CONFIRMING THE  
PREPARATION AND SUBMISSION OF AN APPLICATION FOR FINANCIAL  
ASSISTANCE TO THE NEW JERSEY ENVIRONMENTAL INFRASTRUCTURE  
TRUST FOR THE IMPROVEMENTS TO THE AUSTIN STREET PUMP  
STATION and FORCE MAIN PROJECT**

**WHEREAS**, the Mantua Township Municipal Utilities Authority (“MTMUA”) has determined to undertake a capital improvement program consisting of improvements and upgrades to the Authority’s infrastructure consisting of: (i) Improvements to an existing duplex pumping station to include the replacement of two (2) pumps with associated controls; (ii) Reconfiguration of onsite piping with installation of system bypass capabilities; (iii) restoration/repair of the concrete coating of the existing wet well; (iv) installation of a new electrical utility service and associated electrical components for proper operation of the pumping station and connection to the Authority’s exiting SCADA system; (v) installation/construction of approximately 2,500LF of force main from the existing pumping station to a terminal manhole on either Route 45 or on Capital Drive; (collectively, “Austin Street Pumping Station Improvement Project”), all as more particularly described in the application initiated on H2Loans dated January 9, 2019 by the MTMUA to the New Jersey Infrastructure Bank (“NJIB”) and designated as project number S340514-01; and

**WHEREAS** the MTMUA desires to seek low cost financing from NJIB for the Project (“Project Financing”); and

**WHEREAS**, the MTMUA desires to authorize, approve, ratify and confirm the preparation and submission by its Administrator, Chief Financial Officer, Bond Counsel, Water and Sewer Engineer, Solicitor, Financial Advisor, and/or Auditor on or about May 21, 2019 of an Application for Financial Assistance (“Application”), and other documentation to the NJIB and NJDEP, and permit applications to the NJDEP and other applicable regulatory agencies with respect to the Project and said Project Financing.

**NOW, THEREFORE, BE IT RESOLVED**, by the Chairman and Board of the MTMUA, County of Gloucester, and State of New Jersey as follows:

1. The preparation and submission of the Application(s) for Project Financing and permitting is hereby authorized, approved, ratified and confirmed, and the Executive Director, Foreman/Operation, Engineer, Solicitor, and/or Auditor, along with other representatives of the MTMUA, are hereby authorized to continue to represent the MTMUA in matters pertaining to the Project, the filed Application(s) and the Project Financing.
2. The MTMUA's Executive Director is hereby authorized to act as the MTMUA's Authorized Representative and to represent the MTMUA in all matters relating to the Project, the filed Application(s) and the Project Financing.
3. The MTMUA's Secretary is hereby directed to prepare and file a copy of this Resolution with the NJIB and other applicable regulatory agencies as a part of such Application(s).
4. All other resolutions, or parts thereof, inconsistent herewith are hereby rescinded and repealed to the extent of any such inconsistency.

**THIS RESOLUTION** shall take effect immediately.
