RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY AUTHORIZING EXECUTION OF TREATMENT WORKS APPROVAL FORMS FOR THE AUSTIN STREET PUMPING STATION AND OFFSITE FORCE MAIN

WHEREAS, the Mantua Township Municipal Utilities Authority (MTMUA) requires the execution of Treatment Works Approval (TWA) and Gloucester County Utilities Authority (GCUA) application forms along with application fees, including the Permit Applications and the Statements of Consent, for submission to New Jersey Department of Environmental Protection (NJDEP) and GCUA for replacement of the potable water and sanitary sewer mains located within the Centre City neighborhood in the Township of Mantua; and

WHEREAS, NJDEP and GCUA require the Mantua Township Municipal Utilities Authority's submission and consent for said approval.

WHEREAS, in order to submit said applications there are fees required to submit the applications (1) for the TWA in the amount of \$4,913.04 to be payable to the Treasurer, State of New Jersey, Environmental Services Fund and (2) for GCUA in the amount of \$100.00 payable to the Gloucester County Utilities Authority.

NOW, THEREFORE, BE IT RESOLVED, by the Authority Chairman and Board of the Mantua Township Municipal Utilities Authority of the Township of Mantua, County of Gloucester, and State of New Jersey, as follows:

- 1. That the Mantua Township Municipal Utilities Authority does hereby approve the execution and submission of said TWA & GCUA applications on behalf of the MTMUA as regards to the Austin Street Pumping State and Offsite Force Main.
- 2. That William Krebs and David S. Palgutta are hereby authorized to act on behalf of the MTMUA in order to execute and submit said TWA & GCUA applications and forms necessary on behalf of the Mantua Township Municipal Utilities Authority.
- 3. That the MTMUA is hereby authorized to remit said application fees for the (1) TWA in the amount of \$4,913.04 payable to the Treasurer, State of New Jersey, Environmental Services Fund and (2) payable to the Gloucester County Utilities Authority in the amount of \$100.00.

THIS RESOLUTION shall take effect immediately.
