**RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL
UTILITIES AUTHORITY AUTHORIZING A
SHARED SERVICES AGREEMENT BETWEEN
MANTUA FIRE DISTRICT NO. 1 AND
MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY**

WHEREAS, the Mantua Township Municipal Utilities Authority (“MTMUA”), has its principal place of business at 397 Main Street, Mantua, New Jersey 08051 and the Mantua Township Fire District No. 1 has its principal place of business at 155 East Union Avenue, Sewell, New Jersey 08080; and

WHEREAS, the purpose of the MTMUA is the provisioning of water and sewer services to the residents of Mantua Township; and

WHEREAS, pursuant to the Uniformed Shared Services and Consolidation Act. N.J.S.A. 40A:65-J, et seq., municipalities and other local units may enter into Shared Services Agreements with other governmental units by adoption of a Resolution; and

WHEREAS, Fire District and MTMUA are local units as defined by N.J.S.A. 40A:65-3; and

WHEREAS, Fire District and MTMUA have concluded that their residents and ratepayers will benefit from the sharing of certain defined services; and

WHEREAS, the parties hereto recognize that certain services may be more efficiently provided by one of the parties to the Shared Services Agreement; and

WHEREAS, the proper and respective officials of the local units were authorized to execute the Shared Services Agreement; and


WHEREAS, said Shared Services Agreement which is attached hereto and incorporated herein at length, shall commence on January 2, 2021 and continue through December 31, 2023, unless properly terminated beforehand by the parties; and

NOW, THEREFORE, BE IT RESOLVED by the Mantua Township Municipal Utilities Authority as follows:



The Mantua Township Municipal Utilities Authority does hereby authorize the Shared Services Agreement between the MTMUA and Mantua Fire District No. 1 for the sharing of maintenance and other services as outlined in the attached SSA incorporated herein at length commencing on January 2, 2021 through December 31, 2023, unless properly terminated beforehand by the parties.
