RESOLUTION OF MANTUA TOWNSHIP MUNICIPAL UTILTIES AUTHORITY AUTHORIZING THE BARNSBORO SANITARY SEWER FORCE MAIN EXTENSION

WHEREAS, the Mantua Township Municipal Utilities Authority ("MTMUA"), has its principal place of business at 397 Main Street, Mantua, New Jersey 08051; and

WHEREAS, the purpose of MTMUA is the provisioning of water and sewer services to the residents of Mantua Township; and

WHEREAS, the MTMUA has expressed the need to evaluate its existing infrastructure and the potential for expansion, and residents of Barnsboro Road expressed an interest in connecting to a sanitary sewer main that was recently installed on Barnsboro Road, north of their properties; and

WHEREAS, the Commissioners serving as the MTMUA Board directed that a study be done advising of the technical feasibility of extending the sanitary sewer main further along Barnsboro Road; and

WHEREAS, it was determined that it is technically feasible to extend a Two (2") Inch sanitary sewer force main approximately 800 feet southward on Barnsboro Road, starting from the terminus of the sewer main created by a recently completed project along that road, permitting any residents, at their expense, to connect to the sanitary sewer system upon providing and installing suitable pumping stations with controls to convey the sanitary sewer from their dwellings to the terminal manhole; and

WHEREAS, at the regular meeting of August 17, 2021 the Commissioners of the MTMUA Board voted to extend a 2" sanitary sewer force main approximately 800' southward on Barnsboro Road as hereinbefore stated;

NOW, THEREFORE, BE IT RESOLVED by the Mantua Township Municipal Utilities Authority as follows:

1. The Mantua Township Municipal Utilities Authority Board does hereby direct the MTMUA to install a 2" sanitary sewer force main on Barnsboro Road, thereby extending the sewer main from the current termination point, created by a recently completed project on that road, and running in a south easterly direction for approximately 800 feet.

2. The cost of the extension is not to exceed the sum of twenty-five thousand dollars (\$25,000.00).

3. All connections to the new sewer force main extension will require property owners to provide and install suitable pumping stations with controls to convey the sanitary sewer from their dwellings to the terminal manhole.

4. This Resolution was made, approved and effective September 21, 2021.
