RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY AUTHORIZING PARTIAL PAYMENT NO. 6 TO PERNA FINNIGAN, INC., FOR THE BARNSBORO SANITARY SEWER EXTENSION PROJECT

WHEREAS, the Mantua Township Municipal Utilities Authority (MTMUA), with its principal place of business at 401 Main Street, Mantua, New Jersey 08051 entered into a contract with Perna Finnigan, Inc., of Vineland, New Jersey for the Barnsboro Sanitary Sewer Extension Project; and

WHEREAS, Perna Finnigan, Inc., is seeking partial payment in the amount of \$59,858.01, representing the balance due for the 8" cement lined ductile iron pipe (CLDIP), the furnish portable generator, the 1" K copper water service with curb stop and box, the concrete vertical curb (if and where directed), the hot mix asphalt repair (County roadway requirements) (if and when directed), the excavation, test pit (if and where directed), the pipe bedding (if and where directed) and the select material (if and where directed); and

WHEREAS, Perna Finnigan, Inc., is further seeking partial payment for the 4" sanitary sewer lateral with clean-out (with CC box) (open cut), the 2" high density polyethylene (HDEP) force main with valve (directional drilling), the installation of two (2) combination cleanout/check valves (located at corner of Breakneck Road and Main Street), the pipe bedding (if and where directed), the select material (if and where directed), the traffic stripes, 4", the traffic markings, and the balance of the maintenance and protection of traffic (during roadway construction and sanitary sewer construction).; and

WHEREAS, all certification letters for payment that are subject to the American Iron and Steel (AIS) requirements have been received or shall be submitted; and

WHEREAS, the progress of the work completed has been reviewed and verified and Partial Payment No. 6 is hereby recommended in the amount of \$59,858.01 pursuant to the recommendation of the MTMUA project engineer David S. Palgutta, PE, CME by letter dated September 12, 2022, which is incorporated herein at length; and

WHEREAS, there are contingencies that must be met before payment is released as outlined in the September 12, 2022 Sickles & Associates, Inc. letter, incorporated herein at length, that requires the Contractor and all Subcontractors submit: 1. Certified payrolls in accordance with both New Jersey State Wage Rates and the Davis Bacon Wager Rates for this and all prior pay periods over the duration of this Contract, 2. Current Monthly Project Workforce

Report – Construction (New Jersey Form AA-202) for this and all prior pay periods over the duration of this contract, and 3. Documentation and continuing submission of information regarding its Good Faith Efforts to meet minority and women project participation requirements pursuant to NJIB-NJDEP for this and all prior pay periods over the duration of this contract.

NOW, THEREFORE, BE IT RESOLVED, that the Mantua Township Municipal Utilities Authority hereby authorizes partial payment No. 6 to Perna Finnigan, Inc. in the amount of \$59,858.01 for the additional work completed regarding the Barnsboro Sanitary Sewer Extension project as reflected in the Sickles & Associates, Inc. September 12, 2022 letter contingent upon Perna Finnigan, Inc. complying with the aforesaid requirements as detailed in the September 12, 2022 letter and confirmed to the MTMUA by Sickles & Associates.
