### **RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY AUTHORIZING A PROFESSIONAL SERVICES CONTRACT WITH COMPLETE CONTROL SERVICES, INC.**

**WHEREAS**, the Mantua Township Municipal Utilities Authority has determined that there is a need to appoint a Control Systems Contractor for Fiscal Year 2023; and

**WHEREAS**, pursuant to N.J.S.A. 19:44A-1 *et. seq.*, the Authority advertised for the submission of proposals for a professional service agreement through a fair and open process; and

**WHEREAS**, the Authority received responses and evaluated each professional's ability to meet the Authority's needs, considering all pertinent factors, including but not necessarily limited to, professional merit, qualifications, experience, references, cost competitiveness, and responsiveness to the advertisement.


**NOW, THEREFORE, BE IT RESOLVED**, upon proper motion and vote at a public meeting of the Mantua Township Municipal Utilities Authority, as follows:


1. Complete Control Services, Inc. of 1515 Grant Street, Egg Harbor City, N.J. 08215, is hereby appointed Control Systems Contractor for a period of one year commencing February 7, 2023 until Reorganization, 2024.
2. The Authority's Chairperson and/or Executive Director are authorized to enter into an agreement on behalf of the Authority with Michelle L. Heims, Secretary/Treasurer for Control Systems Services, Inc. or other designated official of the company.
3. The award is subject to a determination that there are sufficient funds in the Authority's Budget for the Agreement.
4. The appointment and contract is awarded pursuant to N.J.S.A. 19:44A-1 *et. seq.*
5. Notice of this Resolution shall be published in accordance with N.J.S.A. 40A:11-5 (1)(a)(i).
