## RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY AUTHORIZING PARTIAL PAYMENT NO. 6 TO B & H CONTRACTING, INC., FOR THE ROYAL OAKS PUMPING STATION IMPROVEMENTS

**WHEREAS**, the Mantua Township Municipal Utilities Authority (MTMUA), with its principal place of business at 401 Main Street, Mantua, New Jersey 08051 entered into a contract with **B & H Contracting, Inc.**, of Folsom, New Jersey for the Royal Oaks Pumping Station Improvements; and

**WHEREAS**, **B & H Contracting**, **Inc.**, is seeking partial payment in the amount of **\$28,518.00**, representing payment for the balance of the mobilization/construction layout, the excavation, test pit(s) (if and where directed), the installation of new fence sections, extend and install new chain link fence sections, match existing fencing in kind, the installation of new double swing gate, and the 6" thick, crushed concrete driveway (pump Station); and

WHEREAS, B & H Contracting, Inc., is further seeking payment for the 3" thick, crushed concrete (fenced area) (pump station site area), the hot mix asphalt, surface course, 12.5M64, 2" thick, the site grading, restoration and stabilization of earthen areas, and the balance of the startup services for muffin monster/grinder within wet well; and

**WHEREAS**, all certification letters for payment that are subject to the American Iron and Steel (AIS) requirements have been received or shall be submitted as part of the payment release; and

**WHEREAS**, the progress of the work completed has been reviewed and verified and Partial Payment No. 6 is hereby recommended in the amount of \$28,518.00 pursuant to the recommendation of the MTMUA project engineer David S. Palgutta, P.E., CME by letter dated June 13, 2023, which is incorporated herein at length; and

**WHEREAS**, there are contingencies that must be met before payment is released as outlined in the June 13, 2023 Sickles & Associates, Inc. letter, incorporated herein at length, that requires the Contractor and all Subcontractors submit: **1.** Certified payrolls in accordance with both New Jersey State Wage Rates and the Davis Bacon Wager Rates for this and all prior pay periods over the duration of this Contract, **2.** Current Monthly Project Workforce Report – Construction (New Jersey Form AA-202) for this and all prior pay periods over the duration of this contract, and **3.** Documentation and continuing submission of information regarding its Good Faith Efforts to meet minority and

women project participation requirements pursuant to NJIB-NJDEP for this and all prior pay periods over the duration of this contract.

NOW, THEREFORE, BE IT RESOLVED, that the Mantua Township Municipal Utilities Authority hereby authorizes partial payment No. 6 to B & H Contracting, Inc. in the amount of \$28,518.00 for the work completed regarding the Royal Oaks Pumping Station Improvements as reflected in the Sickles & Associates, Inc. June 13, 2023 letter contingent upon B & H Contracting, Inc. complying with the aforesaid requirements as detailed in the June 13, 2023 letter and confirmed to the MTMUA by Sickles & Associates.
