**RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL
UTILITIES AUTHORITY AUTHORIZING PARTIAL PAYMENT NO. 7
TO B & H CONTRACTING, INC., FOR THE
ROYAL OAKS PUMPING STATION IMPROVEMENTS**

WHEREAS, the Mantua Township Municipal Utilities Authority (MTMUA), with its principal place of business at 401 Main Street, Mantua, New Jersey 08051 entered into a contract with **B & H Contracting, Inc.**, of Folsom, New Jersey for the Royal Oaks Pumping Station Improvements; and

WHEREAS, B & H Contracting, Inc., is seeking partial payment in the amount of **\$32,243.83**, representing payment for the refurbishing and installing the supervisory control and data acquisition (SCADA) panel associated with the pumping station. The hardware, software and programming with operational and alarm functionality have been provided in accordance with contract requirements; and

WHEREAS, B & H Contracting, Inc., is further seeking payment for the communications and SCADA system improvements be applied to the applicable Owner's project allowance(s) (if and where directed) to cover the costs with the SCADA control panel; and

WHEREAS, all certification letters for payment that are subject to the American Iron and Steel (AIS) requirements have been received or shall be submitted as part of the payment release; and

WHEREAS, the progress of the work completed has been reviewed and verified and Partial Payment No. 7 is hereby recommended in the amount of **\$32,243.83** pursuant to the recommendation of the MTMUA project engineer David S. Palgutta, P.E., CME by letter dated August 4, 2023, which is incorporated herein at length; and


WHEREAS, there are contingencies that must be met before payment is released as outlined in the August 4, 2023 Sickles & Associates, Inc. letter, incorporated herein at length, that requires the Contractor and all Subcontractors submit: **1.** Certified payrolls in accordance with both New Jersey State Wage Rates and the Davis Bacon Wager Rates for this and all prior pay periods over the duration of this Contract, **2.** Current Monthly Project Workforce Report – Construction (New Jersey Form AA-202) for this and all prior pay periods over the duration of this contract, and **3.** Documentation and continuing submission of information regarding its Good Faith Efforts to meet minority and

women project participation requirements pursuant to NJIB-NJDEP for this and all prior pay periods over the duration of this contract.

NOW, THEREFORE, BE IT RESOLVED, that the Mantua Township Municipal Utilities Authority hereby authorizes partial payment No. 7 to **B & H Contracting, Inc.** in the amount of **\$32,243.83** for the work completed regarding the Royal Oaks Pumping Station Improvements as reflected in the Sickles & Associates, Inc. August 4, 2023 letter contingent upon **B & H Contracting, Inc.** complying with the aforesaid requirements as detailed in said August 4, 2023 letter and confirmed to the MTMUA by Sickles & Associates.
