

**RESOLUTION #2023-59**

**RESOLUTION OF THE MANTUA TOWNSHIP  
MUNICIPAL UTILITIES AUTHORITY AUTHORIZING THE AWARD TO  
A.C. SCHULTES FOR REDEVELOPMENT OF WELL NO. 8.**

**WHEREAS**, the Mantua Township Municipal Utilities Authority (“MTMUA”), has its principal place of business at 401 Main Street, Mantua, New Jersey 08051; and

**WHEREAS**, the purpose of MTMUA is the provisioning of water and sewer services to the residents of Mantua Township and there is need for the redevelopment of Well Number 8; and

**WHEREAS**, the purchasing agent has determined and certified in writing that the value of the acquisition will not exceed the bid threshold of \$44,000.00; and

**WHEREAS**, pursuant to the N.J.S.A. 40A:11-6.1, when a contract is below the bid threshold but 15 percent or more of that amount, the Authority is required to solicit at least two competitive quotes, “if practicable,” and

**WHEREAS**, the Superintendent has submitted a technical narrative describing that the solicitation of two competitive quotes is not practicable for this purchase because of the cost, time, and expense to the Authority to remove the pump for assessment will potentially exceed the cost of the repair contemplated herein; and

**WHEREAS**, on September 25, 2023 A.C. Schultes submitted a detailed quote, incorporated herein at length, for the redevelopment of Well No. 8 with the proposed redevelopment cost being \$26,700.00; and

**WHEREAS**, after review of the quote submitted by A.C. Schultes, the Authority has determined that the quote is most advantageous to the Authority in light of price and various other factors; and

**WHEREAS**, the Mantua Township Municipal Utilities Authority has certified that funds are available pursuant to N.J.A.C. 5:30-5.4; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mantua Township Municipal Utilities Authority, as follows:

1. The MTMUA authorizes A.C. Schultes to redevelop Well No. 8 in the amount of \$26,700.00 as outlined in their September 25, 2024 letter.


**BE IT FURTHER RESOLVED** that the Business Disclosure Entity Certification and the Determination of Value be placed on file with this resolution; and
