

## **RESOLUTION #2024-31**

### **RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY AUTHORIZING A CONTRACT FOR LAWN MAINTENANCE SERVICES WITH CALVELLO LANDSCAPING, INC.**

**WHEREAS**, the Mantua Township Municipal Utilities Authority (“MTMUA”), has its principal place of business at 401 Main Street, Mantua, New Jersey 08051; and

**WHEREAS**, the purpose of MTMUA is the provisioning of water and sewer services to the residents of Mantua Township and MTMUA owns numerous facilities in Mantua Township for that purpose; and

**WHEREAS**, maintenance of facilities owned by MTMUA is a necessary and implied duty; and

**WHEREAS**, Mantua Township Fire District No.1 has indicated a desire to sever that portion of the shared services agreement with MTMUA which obligates the Fire District to cut grass MTMUA facilities in the Township; and

**WHEREAS**, quotations for lawn maintenance were requested from three (3) prospective contractors, and only two (2) of the prospective contractors responded and submitted estimates to MTMUA; and

**WHEREAS**, both prospective contractors are qualified to perform the services needed with the lower price from Calvello Landscaping, Inc. of Sewell, New Jersey.


**NOW, THEREFORE, BE IT RESOLVED** by Board of the Mantua Township Municipal Utilities Authority, as follows:

1. MTMUA is hereby authorized to enter into a contract with Calvello Landscaping, Inc., 605 Barnsboro Rd., Mullica Hill, New Jersey, for lawn maintenance services as set forth in Estimate No.4471, dated March 6, 2024, which is attached hereto and incorporated herein at length; and
2. The Executive Director of MTMUA shall execute said contract for and on behalf of the Board; and
3. This Resolution shall be effective immediately upon adoption.
