RESOLUTION OF THE MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY AUTHORIZING SICKELS & ASSOCIATES PROPOSAL 2024-65 FOR PROFESSIONAL SERVICES –

CENTRE CITY WATER & SEWER IMPROVEMENTS – AREA NO. 1
PHASE 1: SANITARY SEWER CLEANING/VIDEO INSPECTION AND
VENDOR ASSISTANCE

WHEREAS, the Mantua Township Municipal Utilities Authority ("MTMUA"), has its principal place of business at 401 Main Street, Mantua, New Jersey 08051 and Sickels & Associates ("S&A") has its principal offices at 833 Kings Highway, Woodbury, New Jersey 08096; and

WHEREAS, the purpose of MTMUA is the provisioning of water and sewer services to the residents of Mantua Township; and

WHEREAS, the MTMUA is continuing the planning and designing process for the rehabilitation/replacement of the potable water and sanitary sewer infrastructure of various areas located within Centre City neighborhood of the Township; and

WHEREAS, due to the scope of improvements being considered, the MTMUA is planning to utilize a phasing approach to replace and/or restore the water and sewer infrastructure in an effort to better address the issues within this area. The Authority is presently in the design phase of the Area No. 1 sanitary sewer improvements and preparing the plans, specifications and bid documents for the project; and

WHEREAS, the scope of this Phase 1 includes the cleaning and video inspections of approximately 100 LF between MH No. 1-9 and MH No. 1-10, crossing Bridgeton Pike (Route 45) as per Sickels and Associates Proposal No. 2024-65 dated June 12, 2024; and

WHEREAS, Phase 1 - Section 1 (Sanitary Sewer Cleaning) will consist of heavy cleaning of 15" sanitary sewer main, crossing Route 45, attempts to remove encrustations/obstructions within 15" main, removal of tuberculation and S&A will coordinate the mechanical cleaning and jetting of the main and monitor cleaning activity; and

WHEREAS, Phase 1 - Section 2 (Sanitary Sewer Video Inspection) will consist of closed circuit televising (CCTV) inspection of cleaned 15" sanitary

sewer main crossing Route 45, Video inspection will be conducted in accordance with National Association of Sewer Service Companies (NASSCO), Pipeline Assessment & Certification Program (PACP) standards, Digital video and NASSCO reports will be provided for the pipe section, S&A will coordinate the video inspection of the mains and monitor video activity and will review video inspection results and identify pipe failures and potential repairs; and

WHEREAS, Phase 1 - Section 3 (Authority to Assist Vendor) will consist of MTMUA providing any local permits, or police detail, if required; provide any traffic control, if required; provide assistance with connection to local fire hydrant and provide authorization to decant into sanitary sewer system; and

WHEREAS, based on the understanding of this project and description of service, the total consulting fees to complete the various activities described in the Sickels and Associates Proposal No. 2024-65 dated June 12, 2024 is estimated at **\$14,740.00** plus cost of applicable reimbursable expenses, which will be invoiced separately; and

WHEREAS, the MTMUA and S&A are authorized to execute Proposal No. 2024-65 provided by S&A included as part of the submission to the MTMUA dated June 12, 2024, which is attached hereto and incorporated herein at length.

NOW, THEREFORE, BE IT RESOLVED by the Mantua Township Municipal Utilities Authority, as follows:

1. The Mantua Township Municipal Utilities Authority does hereby authorize the Director or Chairman to accept the proposal (2024-65) by S&A in the amount of **\$14,740.00** as attached hereto and incorporated herein at length effective June 12, 2024, unless terminated beforehand by the parties.
