

## RESOLUTION #2026 - 27

### RESOLUTION AMENDING THE RULES AND REGULATIONS FOR THE MANTUA TOWNSHIP MUNICIPAL UTILITIES AUTHORITY

**WHEREAS**, the Mantua Township Municipal Utilities Authority, pursuant to applicable law and regulations, previously adopted Rates, Rules and Regulations in May 1977, amended on July 1, 2025, governing the operations of its sewerage and water services in the Township of Mantua; and

**WHEREAS**, the Mantua Township Municipal Utilities Authority, upon recommendation from its Executive Director, deems it necessary and proper to amend the aforesaid rates, rules and regulations set forth in Section 21 - Schedule of Rates; and

**NOW THEREFORE, BE IT RESOLVED**, by the Mantua Township Municipal Utilities Authority that its rates, rules and regulations are hereby amended by Public Hearing held on June 16, 2026, at 5:00 PM and will take effect July 1, 2026.


